FAQ1 *Do the security scanners affect my digital cameras?*

Going through security will not damage your camera, memory cards, CDs, DVDs, jump drives, etc. in any way. Film, on the other hand, will be damaged or ruined by the security scanners. You must protect film (up until it has been developed) in either a lead or barium container.

FAQ2 *Do I need to carry my camera and accessories in my carry on baggage?*

Yes.

FAQ3 *I've heard I cannot bring spare batteries onto a plane. Is this really true?*

Not exactly. The government is somewhat vague on this issue. Go to the following URL for their explanation: <http://www.tsa.gov/travelers/airtravel/assistant/batteries.shtm>. You can save room and weight with a "Go" charger.

FAQ4 *Will my battery charger work in foreign countries?*

Most chargers today are variable voltage and will work correctly. Some may require an adapting tip to fit into overseas outlets. Some older style chargers require a **low** voltage transformer to work in some countries. (A high voltage transformer will not work even though it will power a hair dryer.) The charger will be marked regarding its voltage input requirements.

FAQ5 *Is it less expensive to buy film, memory cards etc. at my destination?*

Only if you want to pay more. U.S. currency isn't 2

FAQ6 *Should I process or print my pictures while I'm away, or wait until I get home?*

Wait for several reasons. Your images on film or memory cards weigh less and take up less room than they will after printing. The weak dollar will also make prints more expensive. Many regions do not use our standard paper sizes or formats. You may end up with sizes you cannot use at home. You will also have little or no recourse if the quality should be below your personal standards.

FAQ7 *Can I watch my video on TVs overseas?*

Probably not. Although the U.S. uses a broadcast system called NTSC, very few other countries do. Other systems are totally incompatible with NTSC. For this reason, DVDs and tapes purchased overseas will not play on your system at home.

FAQ8 *Can I send photos back home using the camera in my phone?*

If the picture is worth taking, use a real camera, not the toy camera built into a phone. If you must use your camera's phone, most cell phones compatible with our systems will not work as phones outside of North America. If you use a real (digital) camera, then your pictures may certainly be sent home via the internet via your or other computers with an online connection.

FAQ9 *If I have a CD burned from images from my digital camera, will I be able to use this CD at home?*

Yes, CDs will be compatible. Most DVDs will not be compatible. Most CDs are universal while DVDs are not.

Later this month the first major shipments of the new 32GB SD memory cards is due to arrive. For those of you requiring Class 6 speed cards for your camcorder, these appear to be quite costly (in the \$450-\$500 range). For SLR cameras and some camcorders the Class 4 speed cards should sell for about half that price.

Owners of beach safe cameras should remember to rinse their cameras off and dry them before opening any doors to change batteries, cards, etc. It only takes a grain of salt to start "electronic cancer".
